Only two more years....

Dear Villagers,

We hope that everyone in Graveney is aware that All Saints' Church, the lovely building sitting on the left edge of the marsh as you pass through the village on the way to Seasalter, is a welcoming place for everyone.

Everyone likes to find an open Church. We have been privileged this year to have had several baptisms and three weddings. We are a small, friendly congregation and love to be open as often as possible to allow people to enjoy the building, tea, cake and conversation. At least three times a month there is worship at 10.30 a.m. and we are glad to be able to serve the village school for Christingle, Harvest and the lovely Leavers' Service.

In 2015 we had to adapt to change when, on the retirement of our dedicated unpaid priest, All Saints joined with the Churches of Boughton and Hernhill and with them we now contribute financially towards our shared Vicar, the Rev. Jean Burrows. This has put special pressure on the finances of the congregation of Graveney Church which previously benefitted from Gill Read's committed and free service.

Those not involved with the way in which parishes are run may not realise the full costs of keeping a Church open for use. The few of us who now regularly attend and manage All Saints (7 members of the Parochial Church Council) work hard to pay the bills by holding fund-raising events such as a recent Auction of Promises and a concert by the Snowdown Colliery Band and by giving of ourselves and our pensions! The sums

raised go towards the costs. Listed below are the weekly figures:

In addition to meeting these costs the congregation reaches out to those in need, raising generous donations to charities for the homeless and contributing hugely to the support of a village in Sierra Leone where two years ago there was an Ebola epidemic. A member of the congregation visited and saw the transformation our gifts had achieved.

Separate initiatives by members of the Friends of Graveney Church raise money towards the fabric of the Church. After six years of hard work the congregation and the Friends, with additional funding from grant-giving bodies, especially the Goodnestone and Graveney Trust, have put the Church building in good order by repairing two side roofs and plastering and redecorating throughout. It is now a pleasure to enter the building, one we would like more of the village to share. We had to raise over £200,000 to achieve this.

Sadly, if we want to keep the Church open for uses which the whole community can share, whether to worship or not, we urgently need wider support. Currently, of those regularly

attending, there are only 4 people who live in the village . . . from some 240 households you will realise how disappointing this is.

This Church has been ministering to the needs of residents since the twelfth century. It should be able to continue for another 900 years. However, current finances and poor attendance mean that we can only hold out for about another two years. Just £1 per week per household could ensure the continued presence in the village of worship and the marking of important events in the lives of every one of you. Parish Council News

The following is an edited summary of the Parish Council meeting held Monday 14th October at 7:30pm in the Village Hall.

Attended by 5 Councillors, Alastair Gould (Borough Councillor), the Clerk and two members of the public.

Matters Arising:

Hernhill Parish Council have been written to regarding stones blocking passing places. The overgrown verge still need reporting and the Clerk will report.

An article about the council responsibilities has been sent for inclusion in the newsletter.

Details of Swale Borough Council Print room shared with the newsletter editor.

Letter regarding the standing order was submitted to the bank.

Speeding on Graveney Road to be raised with Kent County Council ("KCC").

Overgrown vegetation on footpaths has been reported.

A planning comment was made.

Crime Report:

There was no crime report available.

Cleve Hill Solar Park:

The submissions for Deadline 6 have now been published; GREAT made submissions regarding traffic, battery safety and timescale. Network Rail and Kent Fire & Rescue Service also made submissions. GREAT has made a Freedom of Information request regarding the communication between Cleve Hill Solar Park and statutory bodies. The Parish Council made representations regarding traffic and noise. GREAT has commissioned an acoustics report to provide information on noise and vibration. Deadline 7 on 13th November is the last deadline for comments; the enquiry ends on 30th November; the report will then go to the Secretary of State, who will make a decision within three months. A resident raised a query regarding the contingency plan for mitigation should the development go ahead. It was noted that, unlike with London Array, the developer is not legally obliged to provide funding for local enhancements and the danger of asking for mitigation measures is that tacit approval could be assumed. The resident was encouraged to submit comments and representation by Deadline 7.

Village sign landscaping:

The contractor has received a verbal order from Councillor Boggia but is waiting for written confirmation from the clerk.

School flagpole:

The flagpole belongs to the Parish Council; the internal mechanism for raising and lowering the flag is no longer working. The school had obtained a quote for a new flagpole plus installation; the cost of the pole is £328 and installation is £1,026. This was felt to be quite expensive and the need for some installation costs was questioned. It was agreed to ask

another company to visit and assess the pole and quote for the necessary work.

Staffing:

Due to commitments elsewhere, the clerk has resigned, effective at the end of the year. She was thanked for her hard work and support and it was agreed to advertise for a new clerk with local contacts and on the Kent Association of Local Council ("KALC") website. It was agreed that the CiLCA was not a requirement for the role.

Correspondence:

An email had been received from a resident regarding noise from farm workers pushing trolleys across the road and into the field in the early hours of the morning. She had been advised to contact Swale Borough Council if the issue persists.

Large salt bags have been offered by KCC. It was agreed to place one in the school car park if the headteacher is in agreement, and by Councillor Bowles' house if space is available. Clerk to check with headteacher and Councillor Bowles to check space.

A joint meeting for parishes within the Boughton and Courtney ward is being arranged for 31st October. Clerk to check time of meeting.

Finance:

The financial statement and bank reconciliation were reviewed and accepted. A number of small payments were approved.

The budget report for the second quarter was reviewed and accepted.

Planning:

Ewell Farm, Graveney Road – certificate of lawful development for the existing use of land and for the erection of polytunnels for agricultural purposes was approved and noted.

Wheelwrights Cottage, Seasalter Road – removal of branches/crown thinning & crown lifting of trees that pose danger to mains electricity and telephone cables in front of garden. Including work on eucalyptus tree, oak tree, conifer tree and coppice tallest branches from hazel tree. It was agreed not to make a comment.

1 Bridge Cottages, Culmers Terrace – listed building consent for installation of replacement windows (works partially completed). It was agreed to comment with no objection but to question whether the original windows were in fact double glazed. Clerk to make planning comment.

Langdon Manor, Head Hill Road – insertion of a retaining wall to existing pond. Erection of a detached double garage (revised scheme to approved application 19/500193). It was agreed to comment with no objection to the wall but to request that the garage is not used for residential purposes and remains ancillary to the main dwelling. Clerk to make planning comment.

Cleve Hill Farm, Cleve Hill – retrospective application for a change of use of an agricultural building to a storage use. The Parish Council had objected to this application but had drafted a number of conditions which it would wish to be applied if consent was granted. The application was due to be heard at

the Swale Borough Council (“SBC”) planning committee meeting on 10th October but was deferred to the same night as the Parish Council meeting. As a result, it was not possible to send a representative to speak on behalf of the PC, but a written representation had been sent instead.

A response had been received from SBC regarding Lawful Development Certificates, although there was some misunderstanding as the response referred to an application in Dunkirk. SBC recognises the importance of consulting Parish Councils and residents, as they may have local knowledge which should be considered. Clerk to respond to SBC clarifying the application which prompted the query.

Graveney & Goodnestone Trust:

The next meeting is in December; the AGM has taken place. It was noted that this is for members only. Councillor Mitchell is working on a presentation to give at a future PC meeting or a public meeting.

Councillor Reports:

Councillor Bowles: There is a business van regularly parking overnight by the bridge in a dangerous spot. Councillor Mitchell to report.

Councillor King: Had reported a Clancy Docwra van which had been left in the road without sufficient signage while a job was being done. Councillor King had also reported some Southern Water cones on the verge which were causing a minor inconvenience; these are now believed to have been removed.

Councillor Stewart and Councillor King attended the KALC Finance Conference and found it beneficial. Topics covered

included precept setting, the level of reserves, the Annual Governance and Return, having a sound system of internal control throughout the year, risk assessments, disaster recovery, the asset register, the possibility of having dedicated email addresses, the website and communication. It was agreed to consider email addresses when the website is considered.

Reports from Borough and County Councillors:

Councillor Gould reported that the Local Plan Panel is producing a report which envisages an increase in transport of at least 37% if all suggested housing development goes ahead. This will hopefully give some ammunition to fight the housing targets laid down. The use of public transport is being encouraged; this will be the subject of a consultation later in the year. Boughton and Hernhill PCs are looking at possible Traffic Restriction Orders to prohibit HGVs from transiting the villages and will be sending a joint petition to the JTB.

Any Other Business:

It was queried whether a defibrillator could be installed in the villages and whether the Parish Council could organise training to use it. The WI were looking into this at one point. KALC have in the past had deals to purchase defibrillators.

Next Meeting:

The next meeting will be held on Monday 11th September 2019 at 7.30pm.

A Message from your Borough Councillors

September, July and June were all the hottest months ever recorded. In just the last few days. Typhoon Hagibis has caused havoc in Japan, and bushfires have brought destruction to Los Angeles. Closer to home the Isle of Man suffered severe floods, and in other areas of the Midlands, Wales and southern England a week's rain fell in just an hour. Extreme weather events, such as these, are made more likely by our warming climate.

On Friday 20th September 'Strike for the Climate' events, led by children, took place all over the world (including Faversham) to demand action on climate change. It seems a good time to take stock and ask what are we doing to tackle climate change and what more could we do?

Friends of the Earth brought together multiple datasets to examine how each local authority is performing on climate change. (<https://friendsoftheearth.uk/climate-friendly-communities>) Swale came out just above average, but there's a lot more that could be done. These are some of their indicators. (Friends of the Earth's comments are in italics.)

Transport: 24% of commuter journeys are made by public transport, cycling and walking. Swale should aim for *40% by 2030. We need fewer vehicles on the roads – they increase air pollution and are harmful to our health.*

Housing: 39% of Swale homes are well insulated. Poorly insulated homes cost more to run, which is inefficient and

contributes to fuel poverty. *Swale needs to ensure all homes are properly insulated by 2030.*

Renewable energy: Swale has 95 megawatts of renewable energy available. *If the area matched the best of similar local council areas it would have 104 MW. We need 100% clean energy from the wind, sun and sea. Electricity can't come from dirty fuels like coal, oil and gas anymore.*

What is Swale Borough Council doing to improve the situation?

On October 16th, the Policy Development and Review Committee (chaired by Alastair) will review steps to encourage a step change in the number of journeys made by public transport, cycling and walking. It is a very early stage, but later there will be a public consultation. If you have ideas or comments beforehand, please do e-mail Alastair.

We need changes to national government policy to improve energy efficiency of housing in Swale, but the help that is available now can be found at

<https://www.swale.gov.uk/energy-efficient-homes>. A project to provide help for residents in fuel poverty is being planned.

Tim sits on the Planning Committee. The committee have ensured that the care home and hotel to be built at Perry Court will have solar PV panels on the roof and will be heated by a heat pump (which can run on renewable electricity). The supermarket will recover heat from refrigeration to heat the building. There will be two rapid (50Kw) car chargers and eight 7Kw chargers on site.

These are just some of the early actions we are taking to make Swale more environmentally sustainable. Friends of the Earth also highlighted tree cover and waste recycling. We will look at these in a future article.

STOP PRESS!

Petition launches to restrict HGVs through Boughton, Dunkirk and Staplestreet.

The Parish councils of Boughton, Dunkirk and Hernhill , with the backing of Alastair and Tim are asking Kent County Council as Highway Authority to introduce a Traffic Regulation Order to prevent vehicles over 7.5 tonnes using the through route of The Street, Boughton-under-Blean , London Road, Dunkirk, and Staplestreet, Hernhill. KCC Councillor Andrew Bowles has also indicated support

These routes are unsuitable for larger vehicles, and we all know how gridlock can very quickly be created by HGVs and buses travelling in opposing directions meeting along these narrow roads, causing severe disruption for local traffic and residents. The roads were built for a horse and cart, not 44 tonne lorries, and simply cannot take the overspill from the A2 when there are problems there.

News from GREAT



We continue to get good coverage in the Faversham Eye with a further article on Cleve Hill which focuses on the battery storage - <https://www.favershameye.co.uk/post/cleve-hill-the-continuing-story>.

The final deadline in the Examination is 13 November and we are working through all the documents again to ensure we have commented on everything relevant while we still have the opportunity.

The Examiners have issued some final questions for the Applicant (Cleve Hill Solar Park Ltd), including some on their

traffic plan following concerns raised previously about the accuracy of their road measurements. They maintain that it is possible for an HGV and the local bus to successfully pass each other along most of the route, although we all know that isn't the case and we have submitted photos evidencing this!

We have instructed an acoustics company to validate the noise calculations provided by the Applicant and hope to be in a position to submit their report (if appropriate) at the final deadline.

The Examination formally ends on 30 November and the Examiners then have 3 months to prepare their report and recommendation for the Secretary of State. The Secretary of State then has 3 months to make their decision.

Unfortunately we won't know what the Examiners recommendation is until the Secretary of State has made their decision. This means there may be very little to report over the coming months but we are currently looking at ways to increase social and media awareness of the development during this period in an effort to influence the decision maker.

We are encouraged by The Government's recent announcement to delay their decision on the Hornsea 3 wind farm - 120 kilometres off the north Norfolk coast – for 6 months. Natural England raised fears that the huge wind farm would harm the populations of kittiwakes, gannets and the lesser black-backed gull which breed on the east coast. In the recent Examination Hearings, Natural England also voiced concerns about the uncertainty that Marsh Harriers may

consider the changes to Graveney Marshes so great that they would no longer use the area. We are hoping that the same caution will be applied to our case as the one in Norfolk!!

Our website continues to be updated with all the latest news so please do check in regularly!

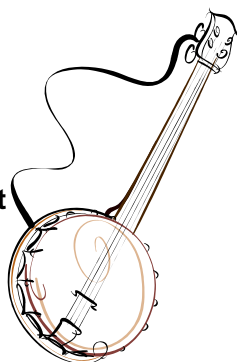
